The period of registration may be extended for additional periods of 5 years each but the total period of registration may not exceed 25 years beginning on the filing date of the application for registration.




Fig.1 Front view




Fig.3 Right side view




Fig.4 Back view




Fig.6 Bottom view




Fig.7 Perspective view
